- 3) We had a table at the Kid's Health Fair on Saturday March 10<sup>th</sup> at 330 Windsor Ave. This was a Town of Windsor event and was a good promotion for us. Jenny met a lot of families and talked about our KIDVID and Middle School program.
- 4) We need people to sign up for Shad Derby day at our booth. There is schedule going around.

Hartford Foundation for Public Giving Grant program Jenny attended. \$7,500 small grant available. The Hartford Committee for Public Giving is granting us \$2,000 for our KIDVID program. Other letters went out today. Konica and PC Development, Rabbett Insurance have sent us checks.

**HACTAC**: No meeting last week due to snow. Hactac wants to meet with station manager to gather details of what they offer their communities, what can they help stations with and any improvements needed.

<u>Technology:</u> Our server is having issues and our channel is shutting down, this system feeds the shows to comcast and streaming. Jenny and Howard have been troubleshooting but it is still happening, Jenny is working with Mike and Leightronix, but this is a difficult problem to solve and we may need to replace unit. Upgrade would cost approx. \$16K -\$20K.
